### IPBC Financials & Preliminary Renewal

The [Annual Comprehensive Financial Report](#) showed that the PPO plans ended FY 24-25 with a loss ratio of 109.4% and a deficit of \$30,306,744. The HMO plans ended with a loss ratio of 102.8% and a deficit of \$2,691,542. The dental plans ended with a loss ratio of 100.6% and a deficit of \$94,160. In addition, the [December 2025 Monthly Financial Reports](#) show the PPO has a YTD loss ratio of 114.8%, HMO has a loss ratio of 102% and the dental has a loss ratio of 96%. These factors are going to negatively impact the renewal. A [preliminary renewal](#) is available. Please remember the information is preliminary and the final renewal will be voted on in March.
